




BUILDING AND ZONING SUMMARY

GENERAL PROJECT DESCRIPTION:


THE PROPOSED ORLANDO MAGIC TRAINING FACILITY IS LOCATED WITHIN THE CITY OF ORLANDO ONE BLOCK NORTHWEST OF AMWAY CENTER. THE 3.781 ACRE SITE IS BOUND BY WEST CENTRAL BOULEVARD AT THE NORTH, SOUTH DIVISION AVENUE AT THE EAST, WEST PINE STREET AT THE SOUTH, AND SOUTH TERRY AVENUE AT THE WEST. THE PROPOSED TRAINING FACILITY IS APPROXIMATELY 100,000 SQUARE FEET PLUS A MEDICAL SERVICE PROVIDER AS AN ATTACHED TENANT OF APPROXIMATELY 35,000 SQUARE FEET. PARKING WILL BE PROVIDED AT GROUND LEVEL VIA A SURFACE LOT AS WELL AS SCREENED PARKING BELOW THE BUILDING FOOTPRINT FOR A TOTAL OF APPROXIMATELY 230 SPACES INCLUDING ACCESSIBLE. CONSTRUCTION ACTIVITIES ARE ANTICIPATED TO BEGIN IN JUNE 2020 AND CONCLUDE IN SEPTEMBER 2021.
