

**FIRST AMENDMENT TO INTERLOCAL AID AGREEMENT
AND
MEMORANDUM OF UNDERSTANDING**

This First Amendment to Interlocal Aid Agreement and Memorandum of Understanding (hereinafter “First Amendment”) is entered into this ____ day of _____, 2020, by and between the City of Winter Park, a municipal corporation organized and existing under the laws of the State of Florida (hereinafter “Winter Park”), and the City of Orlando, a municipal corporation organized and existing under the laws of the State of Florida (hereinafter “Orlando”). The cities of Winter Park and Orlando are collectively referred to herein as the “Parties.”

WHEREAS, the Parties previously executed that certain Interlocal Aid Agreement for Fire Protection and Rescue Services between the City of Winter Park and the City of Orlando, effective on or about August 28, 2017 (hereinafter the “Interlocal Agreement”); and

WHEREAS, pursuant to the Interlocal Agreement, the Parties previously executed that certain Memorandum of Understanding Between the City of Winter Park Fire-Rescue Department and the City of Orlando Fire Department, effective on or about August 29, 2017 (hereinafter the “Memorandum of Understanding”), which provides additional terms governing the Parties’ operations under the Interlocal Agreement; and

WHEREAS, the Interlocal Agreement and Memorandum of Understanding both provide for an expiration date of December 31, 2020, unless extended by written agreement; and

WHEREAS, the Parties wish to renew and amend the Interlocal Agreement and Memorandum of Understanding as provided in this First Amendment; and

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions contained herein, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, agree as follows:

1. **Recitals.** The foregoing recitals are hereby affirmed as true and correct and are incorporated into this First Amendment.

2. **Interlocal Agreement Renewal and Amendment.**

(a) The Parties hereby renew the Interlocal Agreement on all the same terms provided therein except where expressly modified in this First Amendment.

(b) The paragraph of the Interlocal Agreement entitled “Effective Date and Term” is hereby amended to read as follows:

The Agreement shall take effect as of the date last executed by the Parties. The Agreement shall continue in full force and effect through December 31, 2020, after which the Agreement shall automatically renew for successive three-year terms unless either Party informs the other Party of its intent not to renew at least thirty (30) days prior to expiration of the Agreement, or the Agreement is otherwise terminated in accordance with its terms.

3. **Memorandum of Understanding Renewal and Amendment.**

(a) The Parties hereby renew the Memorandum of Understanding on all the same terms provided therein except where expressly modified in this First Amendment.

(b) The paragraph of the Memorandum of Understanding entitled “Effective Date and Term” is hereby amended to read as follows:

The MOU shall take effect as of the date last executed by the Parties. The MOU shall continue in full force and effect for as long as that certain Interlocal Aid Agreement for Fire Protection and Rescue Services between the City of Winter Park and the City of Orlando, effective on or about August 28, 2017, remains in effect, unless the MOU is otherwise terminated or modified in writing.

4. **Effective Date.** This First Amendment shall become effective on the last date executed by the Parties (hereinafter the “Effective Date”).

IN WITNESS WHEREOF, the parties have executed this First Amendment in a manner and form sufficient to bind them as of the Effective Date.
