A PORTION OF THE RIGHT-OF-WAY OF MARIPOSA STREET, SAID ROAD HAVING A 40 FEET WIDE RIGHT OF-WAY, AS SHOWN ON THE PLAT OF J.H. SMITH'S SUBDIVISION OF BLOCK "9" SUMMERLIN'S ADDITION TO ORLANDO, AS RECORDED IN PLAT BOOK "D", PAGE 16, OF THE PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE POINT OF INTERSECTION OF THE EAST RIGHT-OF-WAY LINE OF LAKE AVENUE, SAID ROAD HAVING A 60 FEET WIDE RIGHT-OF-WAY AND THE SOUTH RIGHT-OF-WAY LINE OF MARIPOSA STREET, SAID ROAD HAVING A 40 FEET WIDE RIGHT-OF-WAY, AS SHOWN ON THE PLAT OF J.H. SMITH'S SUBDIVISION OF BLOCK "9" SUMMERLIN'S ADDITION TO ORLANDO, PLAT BOOK "D", PAGE 16, OF THE PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA, SAID POINT ALSO BEING THE NORTHWEST CORNER OF LOT 14 OF SAID PLAT; THENCE N00°37'28"E, ALONG SAID EAST RIGHT-OF-WAY LINE, A DISTANCE OF 40.01 FEET TO THE POINT OF INTERSECTION OF SAID EAST RIGHT-OF-WAY LINE AND THE NORTH RIGHT-OF-WAY LINE OF SAID MARIPOSA STREET, SAID POINT ALSO BEING THE SOUTHWEST CORNER OF LOT 1, OF SAID PLAT: THENCE DEPARTING SAID EAST RIGHT-OF-WAY LINE, N90°00'00"E, ALONG SAID NORTH RIGHT-OF-WAY LINE, A DISTANCE OF 250.00 FEET; THENCE DEPARTING SAID NORTH RIGHT-OF-WAY LINE, S00°37'28"W, PARALLEL WITH AND 250.00 FEET EAST OF SAID EAST RIGHT-OF-WAY LINE, A DISTANCE OF 40.01 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF SAID MARIPOSA STREET: THENCE N90°00'00"W, AI.ONG SAID SOUTH RIGHT-OF-WAY LINE, A DISTANCE OF 250.00 FEET TO THE POINT OF BEGINNING.
