

**AMENDMENT NUMBER FOUR TO  
AGREEMENT EFFECTIVE DECEMBER 1, 2014  
BETWEEN CITY OF ORLANDO AND  
LPS OF AMERICA, INC.**

**THIS AMENDMENT TO AGREEMENT** is made and entered into this \_\_\_\_ day of \_\_\_\_\_ 2020, by and between the City of Orlando, a municipal corporation organized and existing under the laws of the State of Florida, hereinafter referred to as the "City" and LPS of America, Inc., hereinafter referred to as the "Contractor".

***WITNESSETH***

**WHEREAS**, the City and the Contractor entered into an Agreement ("the Agreement") effective as of December 1, 2014, whereby the latter would perform certain services with respect to the Event Parking Services, and

**WHEREAS**, the parties amended the Agreement by date of August 15, 2017; September 11, 2018; and August 19, 2019; and,

**WHEREAS**, the City and the Contractor desire to amend the scope of services of said Agreement to extend the term of the for one (1) year and include Point of Sale (POS) services, handheld equipment and software provided by REEF Technology; and,

**WHEREAS**, LPS of America, Inc. is a wholly owned subsidiary of Reef Global Inc.; and

**WHEREAS**, Reef Global Inc. is also the parent company for REEF Technology, one of its trademark brands;

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

**I. TERM OF AGREEMENT**

The current Term of the Agreement will be extend extended for one (1) year effective, December 1, 2020 through November 30, 2021.

**II. SCOPE**

The Scope of Services and Compensation provisions of the Agreement are hereby amended to add Point of Sale (POS) services including handheld equipment and software and as set forth in the proposal from REEF Technology as "Exhibit "A" attached hereto and incorporated herein by reference. All deliverables as part of the POS services will be PCI compliant.

In all other respects, and except as specifically modified and amended herein and in

Amendment One (1) dated August 15, 2017, Amendment Two (2) dated September 11, 2018, and Amendment Three (3) dated August 19, 2019, the Agreement effective December 1, 2014, shall continue in full force and effect as written and the parties hereto agree to be bound thereby.
