## **Consent Agenda – Commissioner Comments**

**Commissioner Robert F. Stuart** – Commissioner Stuart stated he would wait to provide comments on Item 12-11 Ordinance No. 2023-8 Relating to Alcohol Sales Chapter 33.03 Hours of Service, Sale, and Consumption, under Hearings/Ordinance 2nd Reads until the City Council meeting and had no concerns regarding the agenda.

**Commissioner Patty Sheehan** – Commissioner Sheehan stated she would declare a conflict regarding Item C-3 Meeting Minutes and Approving the Actions of the Municipal Planning Board (MPB) Items: (ANX2022-10017), (GMP2023-10001), and (ZON2023-10001), file a Form 8B Memorandum of Voting Conflict with the City Clerk's Office and will be abstaining from a vote on that item.
